NOMINATION INSTRUCTIONS:

Complete all the information on the nomination form.

SECTION ONE

Provide basic contact information about the person submitting the nomination form. This individual will likely represent the nominated company or individual or be familiar with the company's operations.

SECTION TWO

Provide basic information about the person being nominated, including company size and industry.

SECTION THREE

Explain why the Nominee should be recognized with a Family Business Achievement Award. Provide a brief description that includes the "what", "how", and "why" to support the nomination. Essays can be as short as a single paragraph or as long as necessary to fully explain to the judges the merit of the Nominee. Please keep in mind that the more specific detail provided to the judges, the greater the opportunity the Nominee will have to be recognized.
